ROCK Updates

1. Imaging Classification Committee: Reviewed the classifications PowerPoint with the group at the meeting in July. Additional modifications are pending, including input from Dr Norbert Meenen and his imaging partner Dr. Klaus Bohndorf. Goal is to complete this by Oct 1, 2015
2. Industry Funding.
 - a. Allosource. In final discussion with AS about partial support for the Prospective Cohort
 - b. DJO has declined participation with ROCK and Prospective Cohort
 - c. BREG: In discussion with BREG about studying outcomes for unloader braces for operative and non-operative treatment for OCD. They are likely to offer some support for prospective data collection on unloader braces for all centers
 - d. Imaging. GE and Toshiba do not fund clinical studies, such as MRI Classification. Our radiology group will reach out to Siemens. If any of your imaging division staff have a history of research collaboration with MRI companies, let us know. We will need approx. 25K to complete this study.
3. Image Storage. A work in progress. ROCK Board will receive updates from Eric Wall, Greg Myer, and Jeff Nepple in September.
